AFFIDAVIT

The undersigned Affiant, being duly sworn, deposes and says:

- That, the Affiant, Detective Francis Budwitz, Jr is a regular sworn member of the Department of Public Safety, Division of State Police and has been a member of said department since August 1999. Affiant Budwitz is presently assigned to the Central District Major Crime Squad. Affiant Budwitz has received specialized training in the investigation of violent crimes and how to process the scenes of such crimes. Affiant Budwitz has also participated in numerous criminal investigations that have lead to arrests and convictions.
- That, at all times mentioned herein after, Affiant Budwitz was acting in his official capacity as a law enforcement officer of the State of Connecticut. That the facts and circumstances contained herein are related from personal knowledge and/or observations related to Affiant Budwitz by other persons with personal knowledge of the facts and circumstances contained herein, and / or information learned by Affiant Budwitz from reading reports or writings furnished or made available to Affiant Budwitz by fellow police officers, other state agencies, state employees or citizens.
- That, on Tuesday, June 23, 2009, this affiant was assigned by Connecticut State Police Central District Major Crime Squad Sergeant James Thomas to assist the Connecticut State Police Collision Analysis and Reconstruction Squad with an investigation regarding a fatal motor vehicle collision that occurred on Boston Post Road (Route 1) at the intersection of Dogwood Road in the Town of Orange, Connecticut. The fatal motor vehicle collision resulted in the deaths of two individuals identified as Ashlie Krakowski, white female, date of birth 11/30/1989 and David Servin, white male, date of birth 07/15/1989. The scope of the investigation was to assist the Connecticut State Police CARS Unit with the (24) hour background investigation of the two decedents.
- That, during the above background investigation, this affiant developed information that prior to the fatal motor vehicle accident, the decedents, Krakowski and Servin both minors had attended a 21<sup>st</sup> Birthday Party celebration at the Munro residence located at 117 Heenan Drive in the City of Milford, Connecticut.

**AFFIDAVIT**

The undersigned Affiant, being duly sworn, deposes and says:

5. That, during the investigation, the party location was identified as well as people who attended and the identified person(s) were interviewed regarding the facts and circumstances surrounding this party. The investigation revealed that both person(s) of majority and minors did attend this party and consume alcoholic beverages consisting of beer. That, in addition to beer being available at the party, guests also brought their own alcoholic beverages to consume.
6. That, the host of the party was identified as Jaycen C. Munro, white male, date of birth 06/12/1988 who resides at 117 Heenan Drive in the City of Milford, Connecticut. That, on August 05, 2009 at approximately 1200 hours, Detective Consorte and this affiant interviewed and took a sworn written statement from Munro.
7. That, Munro reported on June 12<sup>th</sup>, 2009 he had a party at his house located at 112 Heenan Road in the City of Milford, Connecticut. Munro reported this party was to celebrate his 21<sup>st</sup> birthday and there were about (15-20) people at the party. Munro reported the party was outside the house where they had a tent and a fire going. Munro reported he had a cooler that was half filled with a (30) pack of beer. Munro reported Cory Brown showed up at about 10:45 PM with Ashlie Krakowski and Dave Servin. Munro reported there were other people with them, but he did not remember who they were. Munro reported Ashlie and Dave showed up and it appeared that they had been drinking before they got to the party because they were buzzed. Munro reported he saw Cory drink a beer or two. Munro reported Dave and Ashlie appeared to be very tipsy when they got to the party and he did not see them drink anything at his party. Munro reported Cory, Ashlie and Dave left the party at about 1:15 AM (06/13/09). Munro reported the next morning he found out that Ashlie and Dave were killed in an accident. Munro reported he saw Cory at the crash site and Cory told him he dropped Ashlie off to get her car. Munro reported the party was over at about 1:30-2:00 AM when he started kicking people out. Munro reported the party went from about 8:00 PM to 1:00 AM. Munro reported it was such a surprise when he found out about the accident because they did not leave his house drunk. Munro reported they appeared to be sober or sobering up when they got to his party. Munro reported Michael DeRosa was there and drank about (20) of the (30) beers Munro had at the party.
8. That, on Thursday, August 13, 2009 at approximately 0900 hours, Detective Consorte and this affiant interviewed and took a sworn written statement from an individual identified as Ayrton S. Torres, date of birth 12/06/1989.
9. That, Torres reported he knew Jaycen Munro from Amity High School as Munro had graduated from high school a year before Torres did. Munro called him to tell him he (Munro) was having a 21<sup>st</sup> Birthday Party for himself at Munro's house in Milford. Torres reported the party was to be held at 9:00 PM on June 12, 2009. Torres reported Munro said there would be beer at the party and Munro knew he was not twenty-one years of age. Torres reported when he got to the Jaycen's house in Milford, he saw it was a party outside the house and there were people all over the place. Torres reported on the left side of Jaycen's house a tent was set up with spotlights and there was a "Beer Pong Table" under the tent. Torres reported mostly everyone was holding cans of beer and only a handful of the people at the party were of legal drinking age. Torres reported he did not see a keg, but believed there was a cooler with beer.

The undersigned Affiant, being duly sworn, deposes and says:

10. That, on Friday, October 09, 2009 at approximately 1115 hours, Detective Consorte and this affiant interviewed and took a sworn written statement from an individual identified as Michael DeRosa, date of birth 07/13/1989.
11. That, DeRosa reported on June 12, 2009, he went to a 21<sup>st</sup> Birthday Party for a friend of his, Jaycen Munro at Jaycen's house in Milford, Connecticut. DeRosa reported he had known Munro from Amity High School and they both graduated in 2007. DeRosa reported Jaycen called him and invited him to the party. DeRosa reported it was also an event on Facebook. DeRosa reported he drove to the party with a friend, Tarek Sakka. DeRosa reported they arrived at the party about 9:00 PM and there were about (25-30) people there. DeRosa reported the party was held outside Jaycen's house in a tent with music and hotdogs and hamburgers. DeRosa reported there were coolers of beer at the party with either Busch or Busch Light Beer. DeRosa reported he consumed (6-10) beers at the party. DeRosa reported there was a beer pong drinking game set up in the backyard. DeRosa reported Ashlie Krakowski and Dave Servin whom he knew from high school arrived at the party about 10:00 PM. DeRosa reported while at the party, he played beer pong against Ashlie and Dave and won. DeRosa reported Ashlie and Dave had to drink (1-2) beers each because they lost.
12. That, on Wednesday, October 14, 2009 at approximately 2006 hours, Sergeant Kevin Stratton and this affiant interviewed and took a sworn written statement from an individual identified as Jason Plaskowitz, date of birth 02/18/1989.
13. That, Plaskowitz reported Jaycen Munro told him about a party he was holding to celebrate his 21<sup>st</sup> birthday about (3) weeks prior to the party. Plaskowitz reported Jaycen's birthday party was on Friday, June 12, 2009 at his home in Milford. Plaskowitz reported he arrived at the party about 7:30-8:00 PM. Plaskowitz reported there were about (20-25) people at the party and the majority of them were of drinking age. Plaskowitz reported the party was outside the house, there was a small fire and a beer pong drinking game. Plaskowitz reported Ashlie and Dave were already at the party by the time they arrived. Plaskowitz reported there was one cooler of beer at the party and he drank about (12) beers throughout the night. Plaskowitz reported there probably about (60) beers in the cooler and it was kind of a BYOB party because Jaycen wanted to keep the party small and not have a lot of people there. Plaskowitz reported he sat with Ashlie for about an hour at the party talking to her by the fire. Plaskowitz reported Ashlie maybe had one or two beers in the hour or so that he was with her. Plaskowitz reported Dave and Ashlie probably had a (12) pack between them.
14. That, on Wednesday, October 14, 2009 at approximately 2040 hours, Detective Consorte and this affiant interviewed and obtained a sworn written statement from an individual identified as Jonathan Bartholomay, date of birth 07/27/1989.
15. That, Bartholomay reported on June 12, 2009, his friend Jaycen Munro had a 21<sup>st</sup> Birthday Party at his house in Milford, Connecticut. Bartholomay reported he heard about the party from Jaycen himself who invited him. Bartholomay reported on the night of the party, Bartholomay drove his car and picked up his friend Mike DeRosa aka."DeRo." Bartholomay reported he and DeRosa arrived at the party at about 10:00-10:30 PM.

**AFFIDAVIT**

The undersigned Affiant, being duly sworn, deposes and says:

16. That, Bartholomay reported at this time, there were approximately (25) people at the party. Bartholomay reported it was an outside party in the backyard area of Munro's house. Bartholomay reported there was food and music at the party as well as some beer. Bartholomay reported seeing a (30) pack of beer under the tent that was set up in the yard next to the food. Bartholomay reported the (30) pack of beer was possibly "Keystone" or "Busch" beer, but he couldn't really be sure. Bartholomay reported under the tent there was a beer pong table set up. Bartholomay reported he remembered he and DeRosa were partners and playing Dave Servin in a game of beer pong. Bartholomay reported he didn't remember who Dave Servin's partner was, but he did remember playing him in beer pong. Bartholomay reported he thought he and DeRosa lost the game so, they probably consumed about (1) beer each while playing beer pong. Bartholomay reported Dave Servin was also drinking beer while playing them in beer pong, but if he had to guess he would say Servin only consumed approximately (1) beer. Bartholomay reported after the game both he and DeRosa stopped playing beer pong as did Dave Servin. Bartholomay reported he only drank about one beer while playing beer pong.
17. That, on Thursday, November 05, 2009 at approximately 2030 hours, Detective Consorte and this affiant met with Jaycen Munro, date of birth 06/12/1988 for a follow-up interview regarding his party on (06/12/09)
18. That, Munro reported he bought a (30) pack of Bud Light Beer for the people he invited to his Birthday Party. That, Munro also acknowledged knowing that Ayrton Torres, (12/06/89), Johnny "B" (Jon Bartholomay, 07/27/89), Cory Brown (01/02/90), Mike DeRosa (07/13/89) and his girlfriend, Sheila Purushotham (08/25/88) were amongst others drinking at the party and he knew they were not twenty-one. Munro stated "Yeah, I knew they weren't twenty-one, but, I made sure they had a ride or that they could stay at my house."
19. That, on Monday, November 09, 2009 at approximately 1246 hours, this affiant spoke with Munro's girlfriend, Sheila Purushotham, date of birth 08/25/2009.
20. That, Purushotham verbally stated the party on June 12<sup>th</sup>, 2009 was for Jaycen's 21<sup>st</sup> Birthday. Purushotham reported Jaycen bought a (30) pack of Bud Light Beer for the party and some people brought their own stuff (alcohol) to the party.
21. That, a State Police Record check revealed no previous criminal history for Jaycen C. Munro, white male, date of birth 06/12/1988.
22. That, at the conclusion of this investigation, the facts and circumstances developed indicated that Jaycen Munro, white male, date of birth 06/12/1988 did host a party at his residence in Milford on June 12, 2009 that extended into the early hours of June 13, 2009. That, Munro did make alcoholic beverages available at this party on private property that was attended by numerous individuals that had not reached the age of majority in the State of Connecticut as well as individuals who were of legal drinking age. That, the minors interviewed admittedly either brought their own alcohol to the Munro party or consumed alcohol that was provided by Munro. That, Munro did allow minors to possess liquor on private property and did not halt such illegal possession.
